RESOLUTION NO. 2006-087

A RESOLUTION EXPRESSING THE WILLINGNESS OF THE CITY GOVERNMENT OF ORMOC TO SHOULDER THE SALARIES OF TEACHERS AND MOOE OF LILO-AN NATIONAL HIGH SCHOOL UNTIL SUCH TIME THAT THE PROPOSED SCHOOL IS ABSORBED IN THE NATIONAL BUDGET.

WHEREAS, a request for the framing of a resolution for the establishment of Lilo-an National High School at Barangay Lilo-an this city was made through 2nd Indorsement dated 09 November 2005 from the Schools Division Superintendent, Ormoc City Division, this city;

WHEREAS, included also in said request was the proposed budget for teachers' salaries and other operating expenses for said school which was forwarded to the Local School Board through this sanggunian;

WHEREAS, a CERTIFICATION was issued dated 02 August 2005 signed by the Honorable City Mayor and the City Treasurer certifying among others that the City Government through the Local School Board is willing to shoulder the salaries of teachers and MOOE of the Lilo-an National High School until such time that the proposed school is absorbed in the National Budget but, however, the same was apparently not sufficient for the needs of the Department of Education Regional Office No. VIII, Tacloban City;

WHEREAS, as pointed out during the Pre-Session Caucus on April 17, 2006 by Mrs. Nelia A. Mancera, Principal, Linao National High School, a resolution from this sanggunian is requested expressing the city's willingness to shoulder the salaries of teachers and MOOE of Lilo-an National High School until such time that the proposed school is absorbed in the National Budget;
