RESOLUTION NO. 2006-095

RESOLUTION RESPECTFULLY REQUESTING THE PRESIDENT AND GENERAL MANAGER OF G S I S, THE HON. WINSTON F. GARCIA, TO REQUEST THE MANAGEMENT OF UNION BANK, TACLOBAN CITY BRANCH, TO RELEASE THE E-CARDS OF G S I S MEMBERS WITHOUT REQUIRING THEM TO PERSONALLY GET IT IN TACLOBAN CITY AS NOT TO INCONVENIENCE THEM AND INCUR TRAVELING AND MEAL EXPENSES JUST TO GET THE E-CARD AND FURTHER REQUEST FOR THE ESTABLISHMENT OF A UNION BANK BRANCH IN ORMOC CITY.

WHEREAS, GSIS members are now required to secure E-CARD in order that they can avail of the benefits and privileges provided for in the GSIS Law;

WHEREAS, GSIS members in Leyte have to go to Tacloban City to secure the aforementioned E-Cards for their picture, specimen signature and forefinger prints taken, and thereafter, are told to come back after one month to personally get their E-Card, and to bring two (2) valid Identification Cards with their picture on it;

this policy of personally getting the E-Cards WHEREAS, enunciated by UNION BANK, and very unfortunately is causing a lot of inconvenience to the members, in the sense that no Union Bank Branch is established in Ormoc City; and also especially the elderly, who have travel hundred of kilometers to Tacloban City, and consequently, spend a substantial amount for their traveling and meal allowances, just to get the processed and accomplished E-Cards;

WHEREAS, other offices of the government which likewise require a similar Card, like the Social Security System, do not require that the processed and accomplished/ID Card should be personally taken by the member-employees, as these are merely sent by registered mail to their respective residents and/or offices, thereby sparing their members of the ordeal in getting personally the ID Card;

FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it

AS IT IS HEREBY RESOLVED, to pass a RESPECTFULLY REQUESTING THE PRESIDENT AND GENERAL MANAGER OF G S I S, THE HON. WINSTON F. GARCIA, TO REQUEST THE MANAGEMENT OF UNION BANK, TACLOBAN CITY BRANCH, TO RELEASE THE E-CARDS OF G S I S MEMBERS WITHOUT REQUIRING THEM TO PERSONALLY GET IT IN TACLOBAN CITY AS NOT TO INCONVENIENCE THEM AND INCUR TRAVELING AND MEAL EXPENSES JUST TO GET THE E-CARD AND FURTHER REQUEST FOR THE ESTABLISHMENT OF A UNION BANK BRANCH IN ORMOC CITY;
