WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated April 10, 2006 from the Office of the City Mayor requesting for a passage of a resolution authorizing the Hon. City Mayor Eric C. Codilla to enter and sign the Memorandum of Agreement (MOA) by and among the LGU - Ormoc, Visayas Consortium for Agriculture and Resources Program (VICARP), Leyte State University, Department of Agriculture - Regional Field Unit 8- and Agricultural Training Institute - National Training Institute;

RESOLVED, FURTHER, that a copy of the final and notarized contract be submitted to the Sangguniang Panlungsod ng Ormoc for information and file;


