WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated April 10, 2006 from the Office of the City Mayor requesting for a resolution authorizing the Hon. City Mayor Eric C. Codilla, to enter into and sign the Memorandum of Agreement by and between the Department of Agriculture - Regional Field Unit 8 and LGU - Ormoc thru the City Agricultural Services Office;

WHEREAS, said MOA refers to the establishment of a technology demonstration (techno-demo) on eggplant production with the use of Trichogramma Chilonis, a biological control agent against shoot and tip borers under the terms and conditions agreed upon by the parties concerned;
