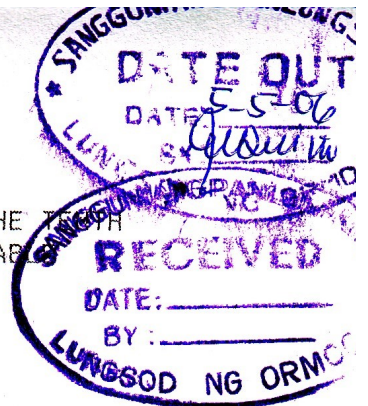

RESOLUTION NO. 2006-103

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE CONSULTANCY CONTRACT, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH THE SPACES-WOODFIELDS-HYDRONET-GENSON JV REPRESENTED BY ENGR. PEDRO ADONIS D. COMPENDIO FOR THE CONDUCT OF DETAILED DESIGN, CONSTRUCTION SUPERVISION AND COMMISSIONING FOR THE REHABILITATION/IMPROVEMENT/EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated 20 April 2006 from the Office of the City Mayor requesting for the passage of a resolution granting authority to the Hon. City Mayor Eric C. Codilla to enter into and sign the Consultancy Contract, for and in behalf of the City Government of Ormoc with SPACES-WOODFIELDS-HYDRONET-GENSON JV represented by Engr. Pedro Adonis D. Compendio for the Conduct of Detailed Design, Construction Supervision and Commissioning for the Rehabilitation/Improvement/Expansion of the Ormoc City Waterworks System;

WHEREAS, in the Notice of Award dated 6 April 2006 the contract price for the said undertaking is TEN MILLION FOUR HUNDRED SIXTY TWO THOUSAND ONE HUNDRED SIXTY PESOS ONLY (P10,462,160.00) under the terms and conditions agreed upon by the parties;

WHEREAS, the said project Repair and Improvement of Water System - Item IV others, was one of those listed under AIP CY 2005;

WHEREAS, this august Body believes that said request is reasonable, hence the same be given due course of action;


