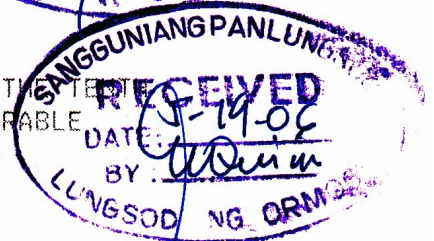
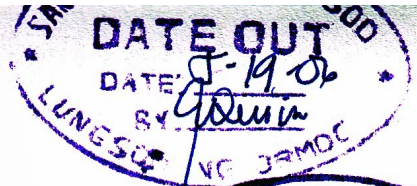

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH HONORABLE EUFROCINO M. CODILLA, SR., REPRESENTATIVE, FOURTH DISTRICT OF LEYTE FOR THE ALLOCATION OF FIVE MILLION PESOS (P5,000,000.00) OUT OF THE CONGRESSIONAL FUNDS AS FINANCIAL ASSISTANCE TO THE CITY OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated May 08, 2006 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Hon. City Mayor Eric C. Codilla to enter into and sign the Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc and Hon. Eufrocino M. Codilla, Sr., Representative, 4th District of Leyte;

WHEREAS, the said Memorandum of Agreement relates to the allocation of FIVE MILLION PESOS (P5,000,000.00) from out of the Congressional Funds as financial assistance to the City of Ormoc to support the proposed health projects of the city;
