

RESOLUTION NO. 2006-118

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE ATTACHED MEMORANDUM OF AGREEMENT, AND CONTRACT OF AFFILIATION (AS AMENDED), BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC AND WESTERN LEYTE COLLEGE OF ORMOC CITY, INC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated May 11, 2006 from the Office of the City Mayor of Ormoc, requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign, in behalf of the City Government of Ormoc, the Memorandum of Agreement, and Contract of Affiliation with Western Leyte College of Ormoc City, Inc., a draft thereof, attached thereto;

WHEREAS, the aforementioned draft of the Memorandum of Agreement, and Contract of Affiliation were indorsed to Dr. Virginia P. Espina, City Health Officer, OIC, for her comments and recommendations;

WHEREAS, Dr. Espina in her 4th Indorsement, dated May 19, 2006, in part states: "X X X this office interposes no objection for the City Mayor to enter into and sign the Memorandum of Agreement and Contract of Affiliation, by and between the City Government of Ormoc and Western Leyte College of Ormoc City, subject to the Department of Health Administrative Order No. 5-A, s. 1996 'Revised policies, procedures and guidelines governing affiliation and training of students in the Department of Health hospitals and other facilities';

WHEREAS, Dr. Espina and Mrs. Jessica C. Solano, R.N. MAN, Dean of the College of Nursing, Western Leyte College, have reviewed the draft of the Memorandum of Agreement, and the Contract of Affiliation, and both agreed to amend the same, and in fact have amended the same, and copy of the amended Memorandum of Agreement, and the Contract of Affiliation were attached to Dr. Espina's 4th Indorsement;

WHEREAS, the Memorandum of Agreement, and Contract of Affiliation, as amended, now considered in this resolution, are subject to the applicable pertinent terms and conditions of Department of Health Administrative Order No. 5-A, s. 1996, a copy of which is hereto attached;

WHEREAS, this august Body believes that the aforementioned request of the Office of the City Mayor is beneficial and reasonable, hence, the same shall be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Eduardo P. Tan, Jose C. Alfaro, Jr. & Cheryl A. Arcuino; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE ATTACHED MEMORANDUM OF AGREEMENT, AND CONTRACT OF AFFILIATION (AS AMENDED), BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC AND WESTERN LEYTE COLLEGE OF ORMOC CITY, INC.;

ADOPTED, 1 June 2006.

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to the Sangguniang Panlungsod ng Ormoc for information and file;
