RESOLUTION NO. 2006-120

A RESOLUTION RETURNING TO THE SANGGUNIANG PAMBARANGAY OF BRGY. DISTRICT VIII, THIS CITY, THEIR ORDINANCE NO. 2006-001, ENTITLED: "AN ORDINANCE REGULATING THE OCCUPATION OF THE SIDEWALKS OF THE CITY STREETS WITHIN THE JURISDICTION OF THIS BARANGAY BY SEASONAL VENDORS PROVIDING PENALTIES IN THE VIOLATION THEREOF" FOR THE REASON THAT SIDEWALKS ARE FOR PUBLIC USE AND THEREFORE ARE BEYOND THE COMMERCE OF MEN.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2006-01 of Brgy. Dist. VIII, this City, entitled: AN ORDINANCE REGULATING THE OCCUPATION OF THE SIDEWALKS OF THE CITY STREETS WITHIN THE JURISDICTION OF THIS BARANGAY BY SEASONAL VENDORS PROVIDING PENALTIES IN THE VIOLATION THEREOF" submitted for review as mandated by Section 57, par. (2) of the Local Government Code of 1991 (RA 7160) in relation to Art. 111 of the Implementing Rules and Regulations of the Local Government Code of 1991;

WHEREAS, the purposes of aforementioned Ordinance, among others, is "to regulate the occupancy of the sidewalks to the commercial activities of man", and "to impose fees for Seasonal Vendors and Individual vendors who occupy Streets and provides penalties for the violation thereof";

WHEREAS, sidewalks and streets are to be devoted to public use and to be made available to the public in general. As such, they are outside the commerce of man and cannot be disposed of or even leased by the Barangay to private persons;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Fe S. Lladoc and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING TO THE SANGGUNIANG PAMBARANGAY OF BRGY. DISTRICT VIII, THIS CITY, THEIR ORDINANCE NO. 2006-001, ENTITLED: "AN ORDINANCE REGULATING THE OCCUPATION OF THE SIDEWALKS OF THE CITY STREETS WITHIN THE JURISDICTION OF THIS BARANGAY BY SEASONAL VENDORS PROVIDING PENALTIES IN THE VIOLATION THEREOF" FOR THE REASON THAT SIDEWALKS ARE FOR PUBLIC USE AND THEREFORE ARE BEYOND THE COMMERCE OF MEN;
