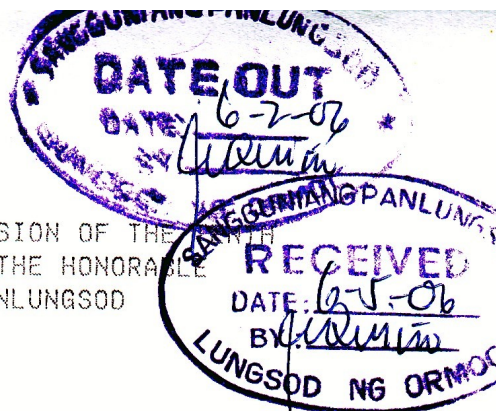

ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF  
BARANGAY ORDINANCE NO. 2003-001, ENTITLED: "AN  
ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE  
FEES OF BARANGAY DISTRICT VIII, ORMOC CITY" BY WAY OF  
MODIFYING THE AMOUNTS FIXED AT EVERY CATEGORY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.  
2006-002 of the Barangay Council of Barangay District VIII, this city,  
entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE  
NO. 2003-001, ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE BARANGAY  
CLEARANCE FEES OF BARANGAY DISTRICT VIII, ORMOC CITY" BY WAY OF  
MODIFYING THE AMOUNTS FIXED AT EVERY CATEGORY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City is, by law, granted the Power to

out that the rates on the issuance of barangay clearances, certificates,  
permits and other charges levied by their barangay are no longer  
commensurate to the services it provides, hence there is a need to  
increase their fees;
