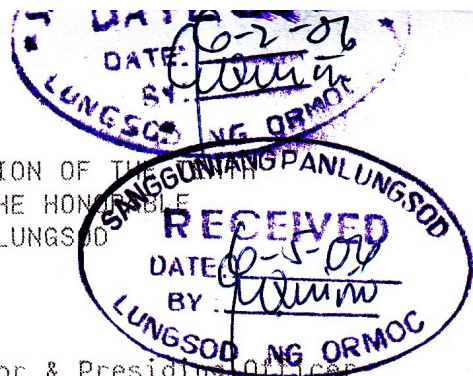

A RESOLUTION ENDORSING TO THE APPROPRIATE AGENCIES CONCERNED THE REQUEST OF THE BARANGAY COUNCIL OF BARANGAY LAO, THIS CITY, THRU BARANGAY RESOLUTION NO. 14 SERIES OF 2006 ENTITLED: "A RESOLUTION REPORTING AND REQUESTING THE GOOD OFFICE OF THE CITY MAYOR, HON. ERIC C. CODILLA, THE SANGUNIANG PANGLUNSOD, DEPARTMENT OF AGRICULTURE - CITY AGRICULTURAL SERVICES OFFICE (DA-CASO) - FISHERY AND AQUATIC DEPARTMENT, CITY ENVIRONMENT AND NATURAL RESOURCES DEPARTMENT (CENRD), CITY ENVIRONMENT AND NATURAL RESOURCES, (CENRO) PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES (PENRO), REGIONAL ENVIRONMENT AND NATURAL RESOURCES (RENRO), DEPARTMENT OF INVIRONMENT (SIC) AND NATURAL (SIC) RESOURCES CENTRAL OFFICE, REGISTER OF DEEDS ORMOC CITY THROUGH THE CITY ASSESSOR'S OFFICE AND THE BUREAU OF INTERNAL REVENUE (BIR) TO PLEASE TAKE PROPER ACTION ON THE ONGOING EXPANSION AND CONSTRUCTION OF FISHPONDS WITH THE JURISDICTION OF BRGY. LAO AND ALSO ON NONE PAYING OF CLEARANCES TO THE BARANGAY AND TO THE BUREAU OF FISHERY AND AQUATIC RESOURCES ON THEIR REPSECTIVE OPERATIONS FOR IT VIOLATES ON LAWS OF TAXES, CONVERSIONS AND ILLEGAL CUTTING OF MANGROOVE (SIC) TREES AND OTHER RELATED LAWS AND ORDINANCES OF THE CITY AND OF THE PHILIPPINES".

WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 14 series of 2006 from Barangay Lao, this city entitled: "A RESOLUTION REPORTING AND REQUESTING THE GOOD OFFICE OF THE CITY MAYOR, HON. ERIC C. ONGOING EXPANSION AND CONSTRUCTION OF FISHPONDS WITH THE JURISDICTION OF BRGY. LAO AND ALSO ON NONE PAYING OF CLEARANCES TO THE BARANGAY AND TO THE BUREAU OF FISHERY AND AQUATIC RESOURCES ON THEIR RESPECTIVE OPERATIONS FOR IT VIOLATES ON LAWS OF TAXES, CONVERSIONS AND ILLEGAL CUTTING OF MANGROOVE TREES AND OTHER RELATED LAWS AND ORDINANCES OF THE CITY AND OF THE PHILIPPINES";

WHEREAS, it is sad to note that illegal fishpond operators continue to operate in the said area, knowing fully well that they are destroying the environment as well as the marine resources inspite of CENRO'S action temporarily stopping the same;

WHEREAS, with this development, this august Body believes that said request be given due course so as to protect the environment and marine resources of the said area and stop the proliferation of illegal fishpond at Barangay Lao, this city;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, jointly seconded by City Councilors Mariano Y. Corro & Manuel T. Fiel; be it
