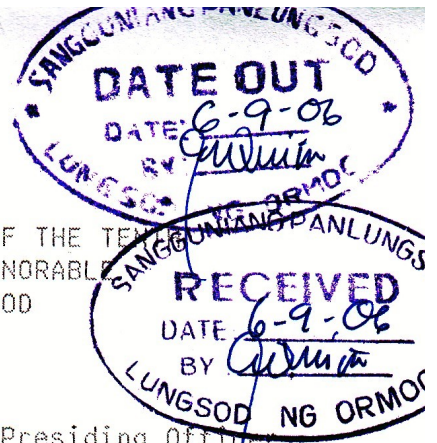

Councilors Fe S. Lladoc & Sotero M. Pepito: be it

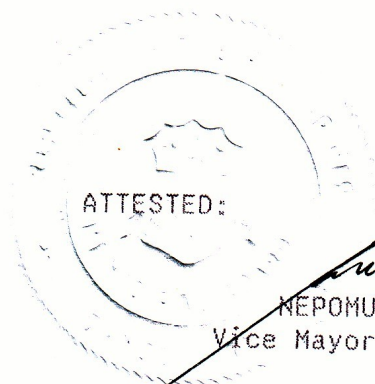
RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DECLARING
