RESOLUTION NO.

A RESOLUTION STRONGLY RECOMMENDING TO THE SOCIAL SECURITY SYSTEM THROUGH ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, NON. CORAZON S. DE LA PAZ, TO UPGRADE THE SSS BENEFITS ESPECIALLY THE RETIREMENT BENEFIT, CONSIDERING SSS BENEFITS HAVE REMAINED STATIC FOR ALMOST A DECADE NOW, NOTWITHSTANDING THAT PRICES OF PRIME COMMODITIES HAVE SKYROCKETED AND THE PURCHASING POWER OF THE PESO HAS PLUMMETED.

WHEREAS, members of the Social Security System who are currently receiving benefits therefrom, and are dependent therewith, find it most difficult to survive with the very meager benefits that they received, specially retirement benefits, due to the skyrocketing of the prices of prime commodities and the erosion of the value of our peso;

WHEREAS, SSS benefits have remain stagnant for almost a decade now, unlike GSIS pensioners who receive an annual increase of their monthly pensions;

WHEREAS, Section 4, par (k) of Rep. Act No. 9257 entitled: "AN ACT TO MAXIMIZE THE CONTRIBUTIONS OF SENIOR CITIZENS TO NATION BUILDING, GRANT BENEFITS AND SPECIAL PRIVILEGES AND FOR OTHER PURPOSES". states:

"retirement benefits of retirees from both the government and private sector shall be regularly reviewed to ensure their continuing responsiveness and sustainability, and to the practicable and feasible, shall be upgraded to be a par with the current scale enjoyed by those in actual service".



WHEREFORE foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, severally seconded by City Councilors Eduardo P. Tan, Ruben R. Capahi & Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution STRONGLY RECOMMENDING TO THE SOCIAL SECURITY SYSTEM THROUGH ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, HON. CORAZON S.
