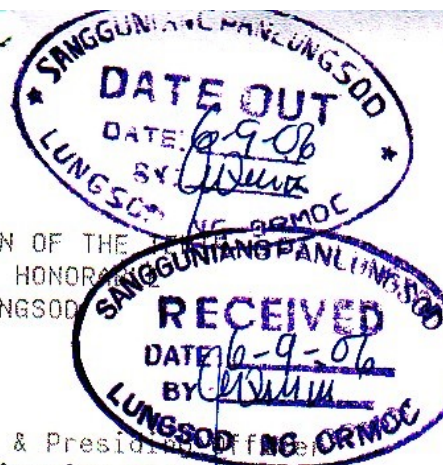

RESOLUTION NO. 2006-131

A RESOLUTION AMENDING SECTION 1 OF RULE IV (STANDING COMMITTEES) OF THE RULES AND PROCEDURES, SPECIFICALLY ON THE COMMITTEE ON SOCIAL WELFARE TO INCLUDE "SENIOR CITIZENS", SO THE COMPLETE TITLE WILL NOW BE "COMMITTEE ON SOCIAL WELFARE AND SENIOR CITIZENS".

WHEREAS, there is an important segment in our society which has not been given the importance it deserves in the organization of the different standing committees of this Sanggunian, the "SENIOR CITIZENS";

WHEREAS, Republic Act No. 7432 as amended by Rep. Act NO. 9257, entitled: "AN ACT TO MAXIMIZE THE CONTRIBUTION OF SENIOR CITIZENS TO NATION BUILDING, GRANT BENEFITS AND SPECIAL PRIVILEGES AND FOR OTHER PURPOSES" emphasizes the importance of Senior Citizens in our community.

WHEREAS, to safeguard the rights and privileges of Senior Citizens as afforded in the aforecited law, it is but fitting that a committee of this Sanggunian should be charged to look after, and promote their welfare;

WHEREAS, the existing Committee on Social Welfare will be charged to look after the welfare of the Senior Citizens, as its functions and concerns are akin to that for Senior Citizens, hence, the title will now be changed to "COMMITTEE ON SOCIAL WELFARE AND SENIOR CITIZENS";

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Internal Rules, jointly seconded by City Councilors Ruben R. Capahi & Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AMENDING SECTION 1 OF RULE IV (STANDING COMMITTEES) OF THE RULES AND PROCEDURES, SPECIFICALLY ON THE COMMITTEE ON SOCIAL WELFARE TO INCLUDE "SENIOR CITIZENS", SO THE COMPLETE TITLE WILL NOW BE "COMMITTEE ON SOCIAL WELFARE AND SENIOR CITIZENS";
