A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.
CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF
UNDERSTANDING BETWEEN ORMOC CITY LGU AND THE
ENVIRONMENTAL MANAGEMENT BUREAU REGION 8.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 05
June 2006 from the Office of the City Mayor respectfully requesting for
the passage of a resolution granting Hon. City Mayor Eric C. Codilla for
an authority to enter into and sign the Memorandum of Understanding
between Ormoc City LGU and the Environmental Management Bureau, Region
8;

WHEREAS, said Memorandum of Understanding (MOU) refers to the
availment by LGU's of the Technical Support for Solid Waste Management
in the Visayas provided by the German Technical Cooperation which will
be implemented jointly with the German consultancy company AHT Group AG
(GTZ-AHT) under the terms & conditions agreed upon by the parties
concerned;

WHEREAS, the Environmental Management Bureau Region 8, (EMB) has a
Memorandum of Understanding with GTZ-AHT to provide solid waste
management technical assistance to LGU's in Region VIII;

WHEREAS, to avail of the assistance of GTZ-AHT, it is necessary to
forge a Memorandum of Understanding with EMB - Region 8;

WHEREAS, this august Body believes that said request is reasonable, hence, the same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources & Environmental Control, duly seconded by City Councilor Mariano Y. Corro; be it


