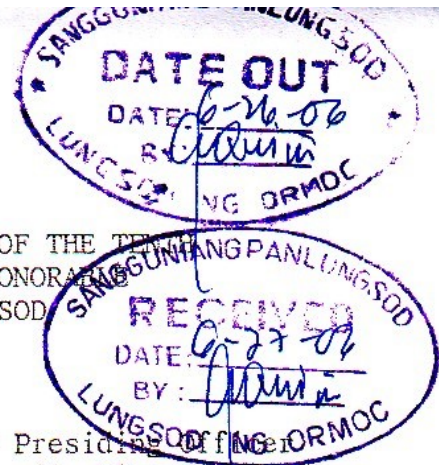


ADOPTED, June 22, 2006.


