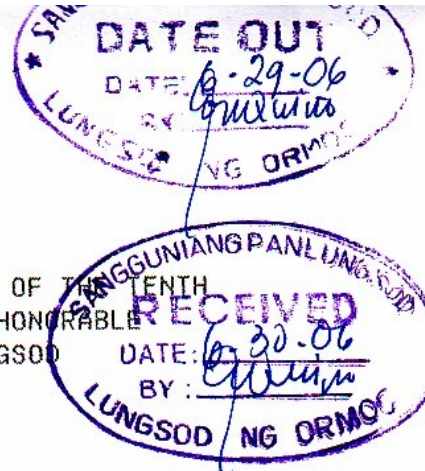

RESOLUTION NO. 2006-144

A RESOLUTION APPROVING ORDINANCE NO. 2006-004 OF THE BARANGAY COUNCIL OF BARANGAY LEONDONI, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC ANIMALS, SUCH AS PIGS, CATTLE, GOATS, DOGS, HORSES, AND FOWLS AS TURKEYS, GEESE, AND SIMILAR ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY, PROVIDING PENALTIES IN VIOLATION THEREOF."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2006-004, from the Barangay Council of Barangay Leondoni, entitled: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC ANIMALS, SUCH AS PIGS, CATTLE, GOATS, DOGS, HORSES, AND FOWLS AS TURKEYS, GEESE, AND SIMILAR (SIC) ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY, PROVIDING PENALTIES IN VIOLATION THEREOF;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation of the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to Review as to whether the said ordinance is consistent with law and city x x x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Leondoni to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Fe S. Lladoc and Sotero M. Pepito; be it
