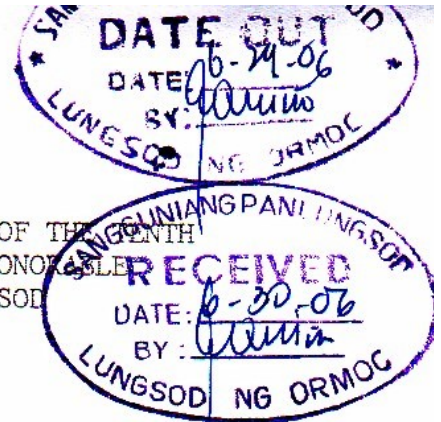

RESOLUTION NO. 2006-145

A RESOLUTION RECOMMENDING TO THE OFFICE OF THE CITY MAYOR OF ORMOC, ERIC C. CODILLA, TO INSTRUCT THE CITY LEGAL OFFICER TO EVALUATE THE REPORT OF THE CITY ACCOUNTING OFFICE AND TO CONDUCT AN INVESTIGATION IN RELATION TO THE QUESTIONABLE PURCHASE OF TREE PLANTING MATERIALS IF STILL NECESSARY AND TO TAKE THE APPROPRIATE LEGAL ACTION AGAINST THOSE PEOPLE INVOLVED IN THE QUESTIONABLE TRANSACTIONS.

WHEREAS, a Memorandum of agreement has been entered into by the Ormoc City LGU and TRANSCO to undertake a tree planting activity to enable TRANSCO to meet its ECC requirement;

WHEREAS, TRANSCO entrusted certain amount of money to the City of Ormoc to be used for the purchase of planting materials and other expenses related thereto;

WHEREAS, the ENRD office is the office concern entrusted to implement the said project;

WHEREAS, the Honorable City Mayor Eric C. Codilla, issued an Office Order S. 2006 dated March 29, 2006 addressed to the City Accountant Mrs. Rosalinda S. Muyuela, directing the latter to conduct an examination/inspection on the TRANSCO reforestation activity of the Environmental & Natural Resources Division (ENRD) the report of which was endorsed to the Honorable Eric C. Codilla dated May 30, 2006;

WHEREAS, said findings and observations revealed that there exist a questionable transactions, copy of said report is hereto attached, including other documents pertinent thereto;

WHEREAS, per records of this Sanggunian, the same person Mr. Carlo S. De La Cruz has been allegedly involved in another questionable transaction concerning government funds;

WHEREAS, the Sangguniang Panlungsod ng Ormoc believes that such actions should not pass without any appropriate disciplinary legal action, hence, this recommendation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources & Environmental Control, jointly seconded by City Councilors Sotero M. Pepito and Mariano Y. Corro; be it


