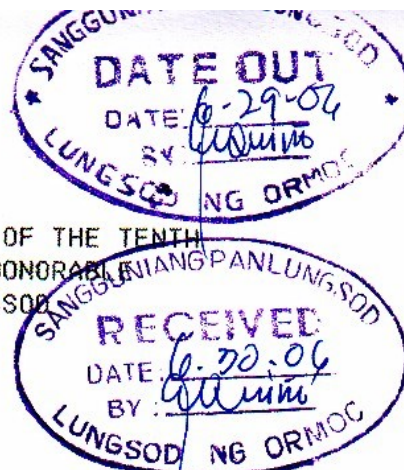

A RESOLUTION REQUESTING PAGCOR TO ADVISE THEIR AGENTS
SPECIALLY THOSE OPERATORS OF PAGCOR INTERNET CASINO
STATIONS (ICS) TO INFORM AND COORDINATE WITH THE LGU
PRIOR TO AND IN RELATION TO THEIR OPERATION SINCE IN
THE EVENT OF ANY PEACE AND ORDER, SANITATION AND SOLID
WASTE MANAGEMENT PROBLEMS THEY WILL BE SEEKING THE
ASSISTANCE OF THE CITY/LGU CONCERNED.

WHEREAS, authority has been granted to Mr. Eduardo J. Dagpin to
operate an PAGCOR accredited Internet Casino Station (ICS) located at
the 2nd Floor, Ormoc Sugarland Pension House, Rizal St., this city,
issued by Rene C. Figueroa, Vice President - Administration, PAGCOR,
Manila;

WHEREAS, this Internet Casino Station is currently operating in the
City of Ormoc without appropriate information and coordination with the
LGU concerned;

WHEREAS, in the eventuality of any untoward incident related to
Peace & Order, sanitation & health and solid waste management, they will
be seeking the assistance of the LGU concerned;

WHEREAS, for the good and peace of mind of all the parties
concerned, who are living in a peaceful community like Ormoc, the City
Council believes that there is a need for proper coordination with the
LGU;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Peace & Order, jointly seconded by City Councilors Claudio P. Larrazabal and Sotero M. Pepito; be it


