RESOLUTION NO. 2006-157

A RESOLUTION INTERPOSING NO OBJECTION AND RECOMMENDING TO  
THE OFFICE OF THE CITY MAYOR HON. ERIC C. CODILLA TO  
ALLOW BARANGAY DISTRICT 12 TO USE A PORTION OF LAND  
CONTAINING EIGHTY (80) SQ. M. MORE OR LESS, AS PER  
SKETCH PLAN ATTACH HERETO, PROVIDED HOWEVER, THAT THE  
SAID LOT SHALL AUTOMATICALLY REVERT TO THE CITY  
(TOGETHER WITH ANY AND ALL IMPROVEMENTS FOUND THEREON)  
IF THE PURPOSE FOR WHICH IT IS INTENDED CEASES TO EXIST  
OR IF THE AREA BECOMES AN EYESORE IN RELATION TO THE  
CITY'S CLEAN AND GREEN PROGRAM.

WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 4  
series of 2006 from the Barangay Council of Barangay District XII this  
city, requesting the City Government of Ormoc thru the Hon. City Mayor  
Eric C. Codilla to donate a parcel of land to be used as Barangay Hall  
site;

WHEREAS, the City Government of Ormoc cannot accede to the request  
of donation but may however, allow the use of the same among other under  
the terms and conditions and in accordance with existing rules and  
regulations;

WHEREAS, per site inspection and evaluation of the documents  
submitted, the City Planning & Development Coordinator, Engr. Raoul E.  
Cam, has found out said request favorable considering that the  
construction of a barangay hall on said lot reserved for city government  
use is a governmental function and is in conformity with Zoning policies  
of the said office and further imposes the following conditions to be  
observed:

- 1) The proposed structure should be limited to one-storey only;
- 2) Further extension and expansion is prohibited.
- 3) Activities must be confined within the requested area of 80 sq. m.
- 4) Structures of the JICA Flood Mitigation Project must not be disturbed during and after the construction phase.
- 5) In case the lot will be utilized by the City Government for future expansion of the plaza, said structure will be demolished or turned over to the City Government.

WHEREAS, this august Body believes that said request is reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Public Properties, duly seconded by City Councilor Sotero M. Pepito; be it




