RESOLUTION NO. 2006-166

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE NEGOTIATED CONTRACT WITH REX C. MORALES CONSTRUCTION FOR THE REPAIR OF ONE (1) STOREY PUBLIC MARKET BUILDING (PHASE II) AT THE ORMOC CITY PUBLIC MARKET.

WHEREAS, this sanggunian is in receipt of 2nd Indorsement dated 24 July 2006 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign the Negotiated Contract with REX E. MORALES CONSTRUCTION for the repair of one (1) storey Public Market Building (Phase II) at the Ormoc City Public Market;

WHEREAS, the City Engineer, Engr. Wilfredo A. Fiel through a letter dated 13 July 2006 has recommended to the City Administrator, Dr. Dennis Y. Capuyan that the repair and renovation of one storey Public Market Building be under REX MORALES CONSTRUCTION through a Negotiated Contract considering that the said subject for negotiation is just contiguous to the said on going Repair/Renovation of similar or related scope of work and that said construction firm has an exemplary contracting capacity and satisfactory performance;

WHEREAS, the Bids & Awards Committee passed a Resolution No. 2006-155 entitled, "A RESOLUTION RECOMMENDING THAT THE REPAIR OF ONE (1) STOREY PUBLIC MARKET BUILDING (PHASE II) AT THE ORMOC CITY PUBLIC MARKET BE UNDERTAKEN THROUGH NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, REX E. MORALES CONSTRUCTION IN THE AMOUNT OF TWO MILLION NINE HUNDRED SIXTY ONE THOUSAND THREE HUNDRED SEVENTY NINE AND 88/100 (P2,961,379.88) PESOS ONLY";



WHEREAS, as stated in said resolution, the justifications mentioned thereat are covered under the conditions for the project to be undertaken by negotiated procurement as provided for in Sec. 53 d of the Implementing Rules and Regulations (IRR-A) of Republic Act No. 9184;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Fe S. Lladoc & Sotero M. Pepito; be it


