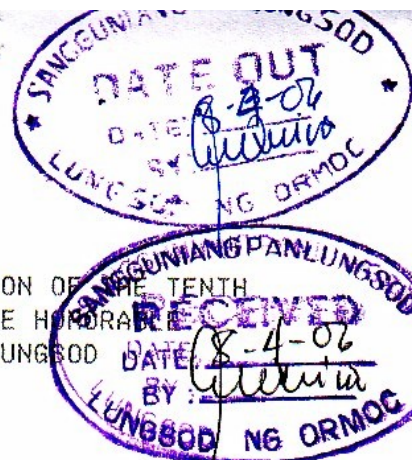

RESOLUTION NO. 2006-167

A RESOLUTION RECOMMENDING TO THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO CONDONE THE PENALTIES IMPOSED ON THE
OFFICE RENTAL OF PHILHEALTH AT THE ORMOC CITY SUPERDOME
AND THAT THEY BE ALLOWED TO PAY THE PRINCIPAL AMOUNT OF
THE UNDERPAYMENT OF ₱3,300 PER MONTH FOR THE PERIOD
JANUARY TO JULY 2006, TO BE PAID NOT LATER THAN AUGUST
10, 2006.

WHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 19
July 2006 from the Office of the City Mayor re: Letter of Atty. Clinton
C. Nuevo, Acting City Legal Officer of the request of Ms. Cristina A.
Laraya, Officer-In-Charge, PhilHealth Ormoc Service Office, requesting
that penalties imposed on their office rental at the Superdome be waived
and allowed them to pay the principal amount only for the period January
to June 2006;

WHEREAS, per contract of lease effective January 2006 entered into
by PhilHealth and the City Government of Ormoc, the former is made to
pay the amount of ₱9,900.00 a month as rental fees at the Superdome,
this city from January 1, 2006 to December 31, 2006;

WHEREAS, however, per letter dated 10 July 2006 of Ms. Laraya, the
processing of said contract was delayed due to no signatories on both
parties and other circumstances affecting its processing, the PhilHealth
Regional Office advised Ormoc PhilHealth to pay the old rate of ₱6,600
until such time that the contract is perfected which is only last June
23, 2006 (date of notarization of the Contract of Lease) thus, incurring
an underpayment of ₱3,300.00 for the period January to July 2006 and the
corresponding penalties;

WHEREAS, this august Body believes that said request is meritorious, hence, be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Jose C. Alfaro, Jr., Sotero M. Pepito, Manuel T. Fiel and Fe S. Lladoc; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RECOMMENDING TO THE HONORABLE CITY MAYOR ERIC C.
