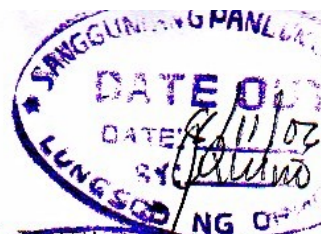
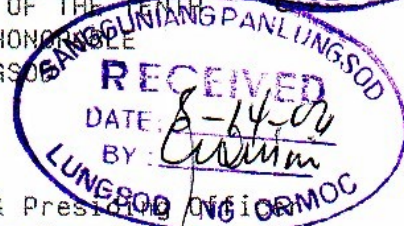

RESOLUTION NO. 2006-175

A RESOLUTION APPROVING THE PROPOSED PROJECTS TO BE FUNDED FROM OUT OF THE CITY'S SHARE OF THE DEVELOPMENT AND LIVELIHOOD FUND OF THE ER 1-94 BENEFITS FROM THE MANANAGDONG AND MALITBOG GEOTHERMAL POWER PLANT AT BARANGAY TONGONAN, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement from the Honorable City Mayor Eric C. Codilla re: Project Proposals to be funded from out of the City's Share of the Development and Livelihood Fund of the ER 1-94 Benefits from the Mahanagdong and Malitbog Geothermal Power Plant at Barangay Tongonan, Ormoc City;

WHEREAS, the Honorable City Mayor through his letter dated 10 August 2006 has requested this august Body thru the Honorable Vice Mayor and Presiding Officer that a resolution be passed on an urgent basis regarding the said project proposals and that the same be endorsed to the Department of Energy, Taguig, Metro Manila, through the NPC-Leyte Geothermal Power Plant;


