RESOLUTION APPROVING THE PROPOSED PROJECTS TO BE FUNDED OUT OF THE CITY'S SHARE OF THE DEVELOPMENT IVELIHOOD FUND OF THE ER 1-94 BENEFITS MANANAGDONG AND MALITBOG GEOTHERMAL POWER PLANT AT BARANGAY TONGONAN, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement from the Nonorable City Mayor Eric C. Codilla re: Project Proposals to be funded from out of the City's Share of the Development and Livelihood Fund of the ER 1-94 Benefits from the Mahanagdong and Malitbog Geothermal Power Plant at Barangay Tongonan, Ormoc City;

WHEREAS, the Honorable City Mayor through his letter dated 10 August 2006 has requested this august Body thru the Honorable Vice Mayor and Presiding Officer that a resolution be passed on an urgent basis regarding the said project proposals and that the same be endorsed to the Department of Energy, Taguig, Metro Manila, through the NPC-Leyte Geothermal Power Plant;

WHEREAS, finding the said request reasonable and meritorious, this august Body believes that the same be accorded the necessary course of action;
