A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH LANDBANK OF THE PHILIPPINES - ORMOC BRANCH FOR THE FACILITATION OF E-CARD WHICH SHALL BE USED BOTH AS ATM AND IDENTIFICATION CARDS, THEREBY, CONVERTING THE LGU EMPLOYEES EXISTING LANDBANK PAYROLL/REGULAR ATM CARDS.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 08 August 2006 from the Office of the City Mayor requesting for the passage of a resolution granting authority to the Hon. City Mayor Eric C. Codilla to enter into and sign the Memorandum of Agreement (MOA) between LANDBANK of the Philippines - Ormoc Branch and the City Government of Ormoc for the facilitation of E-Card which shall be used both as ATM and identification cards, thereby, converting the LGU employees' existing LANDBANK Payroll/Regular ATM Cards;

WHEREAS, LANDBANK of the Philippines - Ormoc Branch has agreed and shall provide the services of conversion and issuance of the E-Card to the employees of the LGU - Ormoc subject to such terms and conditions as maybe mutually agreed upon;


ADOPTED, August 17, 2006.
