RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT BETWEEN WESTERN LEYTE COLLEGE OF ORMOC CITY AND THE CITY GOVERNMENT OF ORMOC FOR THE AFFILIATION OF WESTERN LEYTE COLLEGE WITH THE CITY HEALTH OFFICE OF ORMOC CITY WITH ITS NON-DEGREE HEALTH COURSES.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 24 July 2006 from the Office of the City Mayor requesting for authority to enter into and sign the Memorandum of Agreement by and among Western Leyte College of Ormoc with the City Government of Ormoc for the affiliation of Western Leyte College with City Health Office of Ormoc with its non-degree health courses (Midwifery, Six months courses in Caregiver and Nursing Care Assistant);

WHEREAS, it can be recalled that Western Leyte College has already entered into a similar Memorandum of Agreement with the City Government of Ormoc as to the affiliation of its Bachelor of Science in Nursing course;

WHEREAS, in a letter dated 20 July 2006 from the Office of the President, Western Leyte College, it stated therein that "since the Midwifery, Caregiver Course and Nursing Care Assistant Courses equally need community exposure, we humbly request that another Memorandum of Agreement be made in addition to the existing one for the BSN";

WHEREAS, the Memorandum of Agreement subject of this Resolution is subject to the pertinent or relevant provisions of Department of Health Administrative Order No. 5-A, s. 1996, a copy of which is hereto attached;

WHEREAS, this Body is of the opinion that the aforementioned request from the City Mayor is beneficial, hence the same shall be favorably acted upon;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Health, jointly seconded by City Councilors Eduardo P. Tan and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT BY AND AMONG WESTERN LEYTE COLLEGE OF ORMOC CITY AND THE CITY GOVERNMENT OF CRMOC FOR THE AFFILIATION OF WESTERN LEYTE COLLEGE WITH THE CITY HEALTH OFFICE OF ORMOC CITY WITH ITS NON-DEGREE HEALTH COURSES;

RESOLVED, FINALLY, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the President, Western Leyte College, the City Health Officer and others concerned, -all in Ormoc City;

CARRIED by Nine (9) Affirmative Votes with Two (2) Abstentions registered by City Councilors Manuel T. Fiel and Fe S. Lladoc. The Honorable Vice Mayor & Presiding Officer Nepomuceno P. Aparis I inhibited from the discussion.
