A RESOLUTION FAVORABLY INDORSING AND RECOMMENDING THE PETITION OF BARANSAY CAMP DOWNES TO HER EXCELLENCY MACARAGAL ARROYO, PRESIDENT REPUBLIC OF THE PHILIPPINES TO GRANT OWNERSHIP OF LAND BEING OCCUPIED INFORMAL SETTLERS INSIDE THE MILITARY PER BARANGAY RESOLUTION NO. 029 SERIES OF 2006.

this Sanggunian is in receipt of Barangay Resolution No. Series of 2006 from Barangay Camp Downes, Ormoc City entitled: RESOLUTION REQUESTING THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY, CITY COUNCILOR MARIANO CORRO, KAGAWAD ASSIGNED IN BRGY. CAMP ORMOC CITY, FOR A RESOLUTION ENDORSING THE PETITION OF THE RESIDENTS BRGY. CAMP DOWNES, HERETO ATTACHED, SUPPORTING DOCUMENTS REQUESTING HER EXCELLENCY, GLORIA MACAPAGAL-ARROYO, PRESIDENT OF THE REPUBLIC OF TO GRANT OWNERSHIP OF LAND BEING OCCUPIED BY THE SETTLERS INSIDE THE MILITARY RESERVATION THROUGH A PRESIDENTIAL PROCLAMATION AND THAT THE CITY INTERPOSES NO OBJECTION OF THE AREA REQUESTED FOR PROCLAMATION;

WHEREAS, as mentioned in said resolution, these informal settlers inside the Military reservation area are members of the Camp Downes Homeowner's Association who have introduced improvements such as Barangay Hall, Tennis Court, Barangay stage, drainage, outposts, waiting sheds, Day Care Center, Health Center and many others;



WHEREAS, the petitioning residents of Brgy. Camp Downes, this city have been occupying this portion of the military reservation (Camp Downes) for a very long time now by building their residential homes, and raising their families thereat; hence, it can be rightfully and correctly presumed that this portion of the military reservation is no longer needed by our military authorities, and can now be appropriately released as such; so that actual occupants thereat who are mostly families of military servicemen, former military servicemen, and war veterans, be considered as rightful owners of the lots they are now presently occupying;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution FAVORABLY INDORSING AND RECOMMENDING THE PETITION OF BARANGAY CAMP DOWNES TO HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT REPUBLIC OF THE PHILIPPINES TO GRANT OWNERSHIP OF LAND BEING OCCUPIED BY THE INFORMAL SETTLERS INSIDE THE MILITARY RESERVATION PER BARANGAY RESOLUTION NO. 029 SERIES OF 2006;
