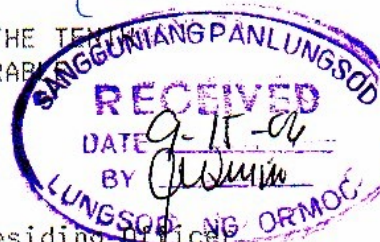

ADOPTED, September 14, 2006.


