- Market Stall Fees 10% discount if monthly rental is paid within three days (3) of the calendar month which is considered as advance payment per Tax Ordinance Nos. 93-01 dated 2/26/93; 67 dated 1/14/99; 70 dated 6/10/99.
- Water Bills 5% discount if paid within 15 days upon receipt of bills per Sec. 2 of Tax Ordinance No. 99-02 dated April 15, 1999.
- Real Property Tax 10% discount for prompt payment and 20% C. for advance payment per Sec. 53 of Tax Ordinance No. dated June 17,. 2003.
