

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.
CODILLA TO ENTER INTO AND SIGN THE ATTACHED MEMORANDUM
OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT
OF ORMOC AND SAN LORENZO RUIZ COLLEGE OF ORMOC.

WHEREAS, this Sanggunian is in receipt of the Indorsement dated
September 21, 2006 from the Office of the City Mayor of Ormoc,
requesting for the passage of a resolution authorizing the Honorable
City Mayor Eric C. Codilla to enter into and sign, in behalf of the City
Government of Ormoc, the Memorandum of Agreement with San Lorenzo Ruiz
College of Ormoc, a draft thereof which is attached hereto;

WHEREAS, the aforementioned draft of the Memorandum of Agreement
was indorsed to Dr. Nelita D. Navales, M.D. M.P.H., City Health Officer,
OIC, for her comments and recommendations;

WHEREAS, Dr. Navales in her Endorsement dated September 20, 2006 in
part states: "X X X this office interposes no objection" to the
Memorandum of Agreement provided however that the school "shall have
been accredited with the CHED and the DOH";

WHEREAS, Mr. Robel L. Sardan, RN, MAN, Dean of the College of
Nursing of San Lorenzo Ruiz College of Ormoc, has assured that the
school is duly accredited with CHED and the DOH;

WHEREAS, the Memorandum of Agreement now considered in this
resolution, are subject to the applicable and pertinent terms and
conditions of Department of Health Administrative Order No. 5-A, s.
1996, a copy of which is hereto attached and deemed incorporated in the
Memorandum of Agreement;


ADOPTED, September 21, 2006.
