

RESOLUTION NO. 2006-210

A RESOLUTION REMINDING THE CITY GOVERNMENT OFFICIALS AND  
EMPLOYEES OF ORMOC TO OBSERVE THE PROVISIONS OF R.A.  
NO. 8491, OTHERWISE KNOWN AS "FLAG AND HERALDIC CODE OF  
THE PHILIPPINES" DURING THE FLAG-RAISING AND FLAG-  
LOWERING CEREMONIES.

WHEREAS, Section 21, of R.A. No. 8491, provides: "During the Flag-raising ceremony, the assembly shall stand in formation facing the flag. At the moment of the first note of the anthem is heard, everyone in the premises shall come to attention, moving vehicles shall stop. All persons present shall place their right palms over their chests, those with hat shall uncover; while those in military, scouting, security guard, and citizens military training uniforms shall give the salute prescribed by their regulations, which salute shall be completed upon the last note of the anthem.

The assembly shall SING the Philippine National Anthem, accompanied by a band, if available, and at the first note the flag shall be raised briskly.

The same procedure shall be observed when the flag is passing in review or in parade.

WHEREAS, Section 22 of the aforecited law, provides: "During the flag lowering, the flag shall be lowered solemnly and, slowly so that the flag shall be down the mast at the sound of the last note of the anthem. Those in the assembly shall observe the same deportment or shall observe the same behavior as for the flag-raising ceremony.

WHEREAS, Section 48 of the said Law, provides: "Failure or refusal to observe the provisions of this Act, and any violation of the corresponding rules and regulations issued by the Office of the President, shall after proper notice and hearing, shall be PENALIZED by PUBLIC CENSURE which shall BE PUBLISHED at least once in a newspaper of general circulation. x x x"

WHEREAS, it is sad to note that during the flag-raising ceremony only a few sing the National Anthem.

WHEREAS, the Declaration of Policy of the aforementioned law, states: "Reverence and respect shall at all times be accorded the flag, the anthem, and other national symbols which embody the national ideals and traditions and which express the principles of sovereignty and national solidarity x x x."

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Manuel T. Fiel, Eduardo P. Tan, Claudio P. Larrazabal and Sotero M. Pepito; be it


