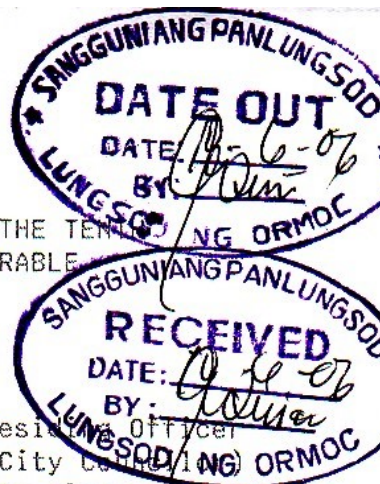

RESOLUTION NO. 2006-215

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE NEGOTIATED CONTRACT WITH D. MORALES ENGINEERING WORKS FOR THE RENOVATION OF BUS TERMINAL (PHASE II) IN THE AMOUNT OF TWO MILLION FOUR HUNDRED SIXTY NINE THOUSAND THREE HUNDRED EIGHTY NINE PESOS & 71/100 (P2,469,389.71) ONLY.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated 28 September 2006 from the Honorable City Mayor requesting for the passage of a resolution authorizing him to enter into and sign the Negotiated Contract with D. Morales Engineering Works for the Renovation of Bus Terminal (Phase II) in the amount of TWO MILLION FOUR HUNDRED SIXTY NINE THOUSAND THREE HUNDRED EIGHTY NINE PESOS & 71/100 (P2,469,289.71) only;

WHEREAS, the Bids and Awards Committee passed Resolution No. 2006-198 dated 21 September 2006 entitled: "A RESOLUTION RECOMMENDING THAT THE RENOVATION OF BUS TERMINAL (PHASE II), ORMOC CITY, BE UNDERTAKEN THROUGH NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, D. MORALES ENGINEERING WORKS IN THE AMOUNT OF TWO MILLION FOUR HUNDRED SIXTY NINE THOUSAND THREE HUNDRED EIGHTY NINE AND 71/100 (P2,469,389.71) ONLY;

WHEREAS, said BAC Resolution No. 2006-198 has cited justifications for said negotiated contract and that the same is in accordance with Sec. 53 d of Republic Act 9184;

WHEREAS, this august Body believes that said request is reasonable, hence the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance, jointly seconded by City Councilors Sotero M. Pepito and Cheryl A. Arcuino; be it


