


A RESOLUTION DECLARING FIFTY ONE (51) BARANGAYS OF ORMOC
CITY UNDER THE STATE OF CALAMITY BASED ON THE
RECOMMENDATION OF THE ORMOC CITY DISASTER COORDINATING
COUNCIL AND SUPPORTED BY VALIDATED REPORTS COMING FROM
THE DIFFERENT CONCERNED AGENCIES OF ORMOC CITY LGU.

WHEREAS, this Sanggunian is in receipt of a recommendation of the
Ormoc City Disaster Coordinating Council recommending for the
declaration of fifty one (51) barangays of Ormoc City under the State of
Calamity based on various validated reports coming from different
concerned agencies of the LGU, Ormoc;

WHEREAS, this recommendation is a very pertinent document for a
declaration of a state of calamity of particular areas which suffered
damages brought about by typhoon Milenyo;

WHEREAS, Sec. 4 a, a4 of the Rules and Regulations Implementing
Republic Act 8185, "AN ACT AMENDING SECTION 324 (d) R.A. NO. 7160,
OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991" provides that:


