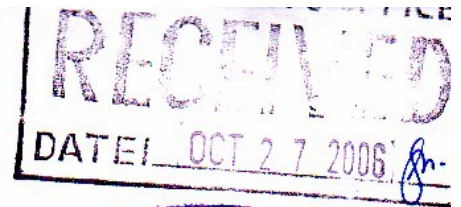
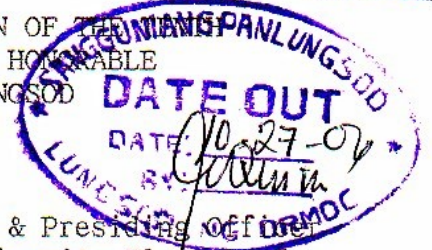

RESOLUTION NO. 2006-228

A RESOLUTION COMMENDING THE ORMOC CITY DISASTER  
COORDINATING COUNCIL (CDCC) EXECUTIVE OFFICER  
HONORABLE JOSE C. ALFARO, JR. FOR HIS UNTIRING EFFORTS  
AND ITS EFFECTIVE, WELL-COORDINATED AND SWIFT ACTION IN  
THE CONDUCT OF SEARCH, RESCUE AND RETRIEVAL OPERATIONS  
DURING TYPHOON MILENYO.

WHEREAS, Ormoc City and other parts of the country suffered the  
fury of Typhoon "Milenyo" last September 27, 2006 and for several more  
days thereafter;

WHEREAS, Ormoc City in particular was adversely affected by the  
said typhoon, with large areas of the City being flooded thereby  
endangering lives and damaging properties and agricultural products;

WHEREAS, those barangays which really suffered the most were those  
which were flooded, rendering the residents therein almost totally  
helpless and at the mercy of the elements;

WHEREAS, the Ormoc City Disaster Coordinating Council (CDCC) played  
a key role in the search, rescue and retrieval operations that had to be  
undertaken at the height of the typhoon and as a consequence thereof;

WHEREAS, the CDCC under the leadership of Hon. Jose C. Alfaro, Jr.  
performed its role in an efficient and timely manner, thereby ably  
responding to the numerous emergency calls for help from the many  
residents residing in the flood-hit areas;



WHEREAS, the CDCC, in showing an effective, efficient and team-oriented effort, was thus able to provide the much needed help and emergency rescue and assistance to the many Ormocanons who were adversely affected by Typhoon "Milenyo";

WHEREAS, had it not for the CDCC's team effort, many Ormocanons would have suffered even more damage, and perhaps there would have been many more fatalities in the City of Ormoc during the typhoon;

WHEREAS, City Councilor Ruben R. Capahi was himself a beneficiary of the timely and efficient efforts of the CDCC, having had to call the Hon. Jose C. Alfaro, Jr. in order to ask for emergency rescue along the flooded highway at the boundary of Brgys. Lilo-an and Licuma, Ormoc City;

WHEREAS, City Councilor Ruben R. Capahi, having personally experienced and having benefited from the efficient, timely and effective rescue efforts of the CDCC has asked for the privilege of sponsoring this Resolution;

NOW, THEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it



ADOPTED, October 26, 2006.


