RESOLUTION NO. 2006-230

A RESOLUTION OF APPRECIATION, COMMENDATION AND THANKS TO
HER EXCELLENCY GLORIA M. ARROYO, PRESIDENT OF THE
REPUBLIC OF THE PHILIPPINES, HON. THELMO CUNANAN,
CHAIRMAN, SOCIAL SECURITY COMMISSION, AND HON. CORAZON
S. DE LA PAZ, PRESIDENT AND CHIEF EXECUTIVE, SOCIAL
SECURITY SYSTEM, FOR INCREASING BY TEN PERCENT THE
MONTHLY PENSION BENEFITS TO SSS MEMBERS, EFFECTIVE
SEPTEMBER 2006.

WHEREAS, on June 8, 2006, this august Body, adopted Res. No. 2006-130, entitled: "A RESOLUTION STRONGLY RECOMMENDING TO THE SOCIAL SECURITY SYSTEM, THROUGH ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, HON. CORAZON S. DE LA PAZ, TO UPGRADE THE SSS BENEFITS ESPECIALLY THE RETIREMENT BENEFIT, CONSIDERING THAT SSS BENEFITS HAVE REMAINED STATIC FOR ALMOST A DECADE NOW, NOTWITHSTANDING THAT PRICES OF PRIME COMMODITIES HAVE SKYROCKETED AND THE PURCHASING POWER OF THE PESO HAS PLUMMETED";

WHEREAS, last October 20, 2006, during the 32nd Philippine Business Conference (PBC) at the Manila Hotel, at the prodding of her Excellency President Gloria M. Arroyo, Hon. Thelmo Cunanan announced that starting September 1, 2006, SSS will implement a 10% across the board increase in the monthly pension benefits to its member; (Source: Phil. WHEREAS, this good news, anent the increase in the monthly pension benefits to SSS members, is most welcomed and appreciated, for at last a break, after a long draught, so to speak, has been given to SSS members, the first under the Arroyo Administration; hence, it is hoped and prayed that this will not be the last, but just the beginning of the many good things to come;

WHEREAS, to show the gratitude of the members of SSS, this august Body has opted to adopt this Resolution;

WHEREFORE, premises considered, on MASS MOTION of the Body; be it


