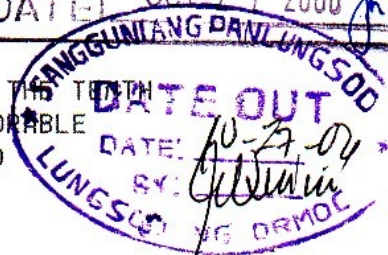

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH DED/GERMAN DEVELOPMENT SERVICE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 16 October 2006 from the Office of the City Mayor requesting for the passage of a resolution granting the Honorable City Mayor Eric C. Codilla an authority to enter into and sign the Memorandum of Agreement with DED/GERMAN DEVELOPMENT SERVICE;

WHEREAS, said Memorandum of Agreement (MOA) mentions of the deployment by DED of a development voluntary worker whose job description, benefits the Solid Waste Management Programs of the city and subject to the terms and conditions agreed upon by the parties;
