A RESOLUTION TEMPORARILY CLOSING SAN PEDRO STREET, FROM PORTION OF CORNER AVILES STREET AND OBRERO STREET, SPECIFICALLY THE AREA FRONTING THE CORNER OF ORMOC VILLA MOTEL ON OCTOBER 28 FROM 6:00 P.M. TO 4:00 A.M. OF GCTOBER 29 AND ON OCTOBER 31 ALSO FROM 6:00 P.M. TO 4:00 A.K. OF NOVEMBER 1, 2006.

WHEREAS, this Sanggunian is in receipt of a letter dated 26 October 006, from the Honorable Maria Samuel P. Aviles, Brgy. Chairman, District XII this city endorsing the request of NOSOTROS VENTURES ENTERTAINMENT CORP. for the closure of San Pedro Street from the juncture of Aviles and Obrero Streets on October 28 and October 31, 2006 between the hours of 6:00 P.M. to 4:00 A.M.;

WHEREAS, the authority to temporarily close and open any local road, alley, park and square is vested in the Sangguniang concerned;

WHEREAS, Sec. 21 (d) of the Local Government Code of 1001 provides that:

Sec. 21 (d)

Any city, municipality, or barangay may, by a duly enacted ordinance temporarily close and regulate the use of any local street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping area may established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispersed to the general public; (Underscoring Supplied)
