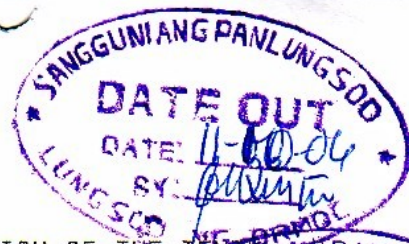

RESOLUTION NO. 2006-238

A RESOLUTION RETURNING TO THE SANGGUNIANG PAMBARANGAY OF DISTRICT 7, THIS CITY, THEIR BARANGAY ORDINANCE NO. 2006-001, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2003-001 ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE FEES OF BARANGAY DISTRICT, ORMOC CITY" BAY (SIC) WAY OF MODIFYING THE AMOUNTS FIXED AT EVERY CATEGORY" FOR AMBIGUITY SPECIFICALLY SEC. 2, PAR. I SUBPAR (e) THEREOF.

WHEREAS, this Sanggunia is in receipt of Barangay Ordinance No. 2006-001, entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2003-001 ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE FEES OF BARANGAY DISTRICT 7, ORMOC CITY" BAY (SIC) WAY OF MODIFYING THE AMOUNTS FIXED AT EVERY CATEGORY";

WHEREAS, aforecited Barangay Ordinance No. 2006-001, was submitted for review by this Sanggunian as mandated by Sec. 57, of the Local Government Code of 1991;

WHEREAS, upon review it was found out that Section 2, par. 1, subparagraph (e) thereof is ambiguous, for as stated thereat, for Business Clearance for capitalization of P50,000.00 and below, P100.00; for capitalization of P50.00 and above, P200.00. So, if the capitalization is exactly P50,000.00, how much will be the Business Clearance Fee? Hence, there is a need for clarification;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws & Ordinance, severally seconded by City Councilors Sotero M. Pepito, Fe S. Lladoc and Jose C. Alfaro, Jr.; be it
