RESOLUTION NO. 2006-244

A RESOLUTION INFORMING WITH REGRETS, THE SANGGUNIANG PAMBARANGAY OF TAMBULILID, THIS CITY, THROUGH THEIR PUNONG BARANGAY, HON. MAXIMO R. JABALLA, JR., THAT THE SANGGUNIANG PANLUNGSOD NG ORMOC CANNOT GIVE DUE COURSE TO THEIR RES. NO. 06-028, ENTITLED: "A RESOLUTION REQUESTING THE SANGGUNIANG PANGLUNSOD (SIC) THRU THE CITY MAYOR HONORABLE ERIC C. CODILLA TO APPROVE THE RELEASE OF THE ACCRUED 2004 LEAVE CREDITS BENEFIT OF THE BARANGAY OFFICIALS OF BARANGAY TAMBULILID, THIS CITY", FOR THE REASONS STATED HEREIN.

WHEREAS, Barangay Resolution No. 06-028 of the Sangguniang Pambarangay of Tambulilid was indorsed to this august Body for comment and appropriate action by the Office of the City Mayor;

WHEREAS, this Sanggunian does not have the power or authority to approve the release of the accrued 2004 leave credits benefit of the Barangay Officials of Tambulilid, as the Leave Benefits of Barangay Officials are governed by the Rules and Regulations promulgated jointly by the Civil Service Commission, and the Department of Budget and Management, now embodied in Joint Circular No. 1, s. 2004, a photocopy of which is hereto attached for ready reference;



WHEREAS, the Sangguniang Pambarangay of Tambulilid already received CSC Opinion No. 1 s. 2004, Re: Leave Benefits of Barangay Officials dated January 3, 2005; (Please see Sept. 1, 2005 letter of Barangay Chairman, Maximo R. Jaballa, Jr. to Mr. Nelson L. Acebedo, Assistant Commissioner, Civil Service Commission)

WHEREAS, as a result of the receipt of aforementioned CSC Opinion No. 1 s. 2004, Barangay Chairman, Maximo R. Jaballa, Jr. on Sept. 1, 2005 addressed a letter to Mr. Nelson L. Acebedo inquiring "CAN WE BE ALLOWED TO BE COMPENSATED BY OUR ACCRUED LEAVE CREDITS EFFECTIVE ON THE ABOVE DATE (APRIL 15, 2004) HENCE, WE RECEIVED THE COPY OF THE MEMORANDUM ONLY THIS YEAR 2005 AND WE PROCESS THE PERTINENT DOCUMENTS AFTER THE MEMO WAS DISSEMINATED TO THE BARANGAYS."

WHEREAS, the above-query of Barangay Chairman Maximo R. Jaballa, Jr. was answered on August 3, 2005 by Director Dolores B. Bonifacio, the ultimate sentence of which reads: "LIKEWISE, LEAVE CREDITS EARNED SHALL BE CUMULATED UP TO ONE YEAR ONLY AND SHALL BE COMMUTED YEARLY." (Underscoring supplied for emphasis)

WHEREAS, in view of the reply of Director Bonifacio, the most that can be done under the circumstances is to ask for a reconsideration to allow the Barangay Officials of Tambulilid the commutation of the accrued leave credits beginning April 15, 2004, considering that the memorandum pertaining to Barangay Leave Credits was only received by them in 2005, and to this end, the Sangguniang Panlungsod ng Ormoc, by this Resolution gives their whole-hearted support;

WHEREFORE foregoing premises considered, on motion of City Councilor Mariane Y. Corro, jointly seconded by City Councilors Sotero M. Pepito and Manuel T. Fiel; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INFORMING WITH REGRETS, THE SANGGUNIANG PAMBARANGAY OF TAMBULILID, THIS CITY, THROUGH THEIR PUNONG BARANGAY, HON. MAXIMO R. JABALLA, JR., THAT THE SANGGUNIANG PANLUNGSOD NG ORMOC CANNOT GIVE DUE COURSE TO THEIR RES. NO. 06-028, ENTITLED: "A RESOLUTION REQUESTING THE SANGGUNIANG PANGLUNSOD (31C) THRU THE CITY MAYOR HONORABLE ERIC C. CODILLA TO APPROVE THE RELEASE OF THE ACCRUED 2004 LEAVE CREDITS BENEFIT OF THE BARANGAY OFFICIALS OF BARANGAY TAMBULILID, THIS CITY", FOR THE REASONS STATED HEREIN;

ADOPTED, November 16, 2006.
