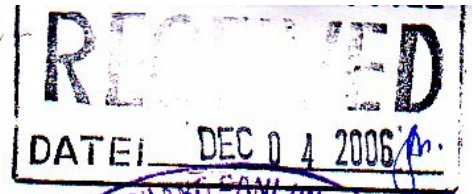

A RESOLUTION APPROVING ORDINANCE NO. 2006-0001 OF THE BARANGAY COUNCIL OF BARANGAY DISTRICT 07, THIS CITY, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2003-001 ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE FEES OF BARANGAY DISTRICT, ORMOC CITY" BY WAY OF MODIFYING THE AMOUNTS FIXED AT EVERY CATEGORY.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2006-01 of the Barangay Council of Barangay District 07, this city, entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2003-001 ENTITLED: "AN ORDINANCE FIXING THE RATES OF THE BARANGAY CLEARANCE FEES OF BARANGAY DISTRICT, ORMOC CITY" BY WAY OF MODIFYING AND AMOUNTS FIXED AT EVERY CATEGORY;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x ordinances; (Sec. 57, 1991 LGC);
