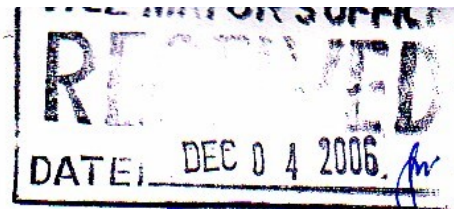
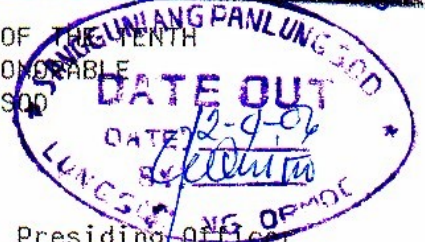

RESOLUTION NO. 2006-255

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH FARMERS BENEFICIARIES OF THE CORN PRODUCTION ENHANCEMENT PROJECT OF ORMOC CITY LOCAL GOVERNMENT.

WHEREAS, this Sanggunian is in receipt of a letter dated 14 November 2006 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) with farmers beneficiaries of the corn production enhancement project of Ormoc City Local Government;

WHEREAS, said MOA mentions of the role of the Ormoc City LGU which is to provide technical assistance and fertilizers to Farmers-Beneficiaries through the City Agricultural Services Office and that the Farmers-Beneficiaries will provide the land area for corn production and attain a target average yield of 5 m.t./ha. during dry season and 4 m.t./ha. during wet season and obliged to insure their corn plant under the Philippine Crop Insurance Corporation (PCIC) in accordance with the terms and conditions agreed upon by the parties;

WHEREAS, this august Body believes that said request is reasonable, hence the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, jointly seconded by City Councilors Ruben R. Capahi and Mariano Y. Corro; be it
