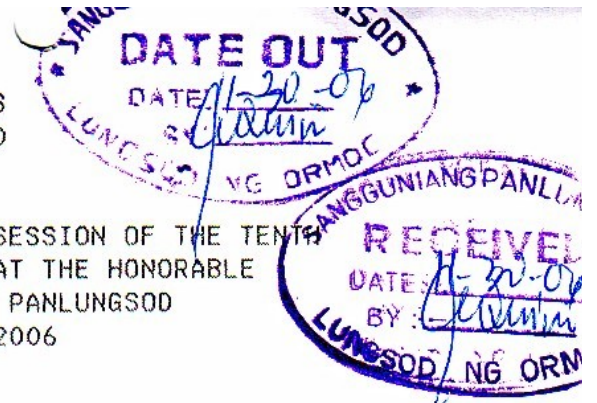

A RESOLUTION TEMPORARILY CLOSING OSMEÑA EXTENSION BRIDGE PARTICULARLY OSMEÑA STREET CORNER MABINI STREET AND THE ROAD ALONG BARANGAY DON FELIPE LARRAZABAL HEADING TO OSMEÑA EXTENSION BRIDGE ON DECEMBER 02, 2006 FROM 12:00 O'CLOCK NOON AND WILL BE OPENED THE FOLLOWING DAY DECEMBER 03, 2006 AT 4:00 O'CLOCK IN THE AFTERNOON, PROVIDED NO PERMANENT STRUCTURES WILL BE BUILT ON THE AFOREMENTIONED AREAS.

WHEREAS, this Sanggunian is in receipt of a letter dated 28 November 2006 from the Honorable City Mayor Eric C. Codilla urgently requesting for the passage of a resolution/ordinance for the temporary closure of the Osmeña Street corner Mabini Street and the road along Barangay Don Felipe Larrazabal heading to Osmeña Extension Bridge on December 02, 2006 from 12:00 noon and will be opened the following day December 03, 2006 at 4:00 o'clock in the afternoon for the purpose of a band showdown dubbed as "FREE CONCERT SA RIVERWALK";

WHEREAS, the authority to temporarily close and open any local road, alley, park and square is vested in the sanggunian concerned;

WHEREAS, the last paragraph of Sec. 21 (c) of the Local Government Code of 1991 states that:

(c) " X X X

Provided, however, That no national or local road, alley, park or square shall be temporarily closed for athletic, cultural or civic activities not officially sponsored, recognized, or approved by the local government unit concerned"; (underscoring supplied)

WHEREAS, this august Body believes, that said request is reasonable considering that the same is part of the forthcoming Christmas Celebration and to promote our newly launched "Riverwalk" as one of our tourist destination;

WHEREAS, foregoing premises considered on MASS MOTION of the Body; be it

ADOPTED, November 30, 2006.


