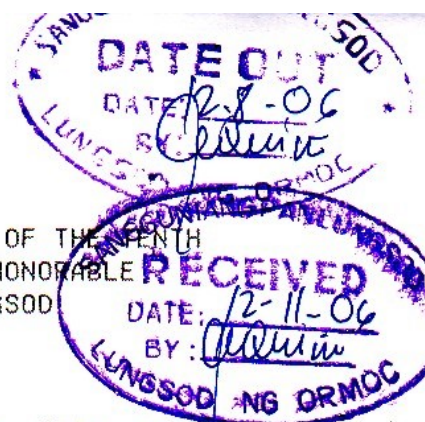

CITY, ENTITLED: "AN ORDINANCE ADOPTING A NEW SCHEDULE
OF FEES FOR THE ISSUANCE OF BARANGAY BUSINESS PERMITS,
CLEARANCES AND CERTIFICATIONS".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
001 Series of 2006 of the Barangay Council of Barangay Camp Downes, this
city, entitled: "AN ORDINANCE ADOPTING A NEW SCHEDULE OF FEES FOR THE
ISSUANCE OF BARANGAY BUSINESS PERMITS, CLEARANCES AND CERTIFICATES";
