DODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF AGRICULTURE-BUREAU OF AGRICULTURE RESEARCH (DA-BAR), EAST WEST SEED PHILIPPINES (EWSCP) AND THE LOCAL GOVERNMENT UNIT OF ORMOC, FOR THE PROMOTION AND COMMERCIALIZATION OF HIGH-VALUE VEGETABLE CROPS IN ORMOC.

MEREAS, this Sanggunian is in receipt of 1st Indorsement from the Office of the City Mayor re: letter of Mr. Marlowe U. Aquino of Department of Agriculture, Bureau of Agricultural Research (DA-BAR) requesting the Honorable City Mayor Eric C. Codilla to fast track the signing of the Memorandum of Understanding in behalf of the Ormoc City LGU with the DA-BAR and EWSCP;

WHEREAS, said Memorandum of Understanding refers to the Promotion and Commercialization of High-Value Vegetable Crops in Ormoc City wherein the goal of the project is to expand vegetable farming in this city thus improving the socio-economic standing of the vegetable growers using only minimum area for production, utilizing an environment friendly vegetable farm practices;
