A RESOLUTION APPROVING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 2 (SERIES 2006) ENTITLED: "A RESOLUTION APPROVING THE REALIGNMENT OF TOURISM FACILITIES IN THE AMOUNT OF ONE MILLION PESOS (\$1,000,000.00) FUNDED UNDER \$0\$ DEV T. FUND (2006 AIP) TO CONSTRUCTION OF TOURISM INFORMATION CENTER IN THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME".

WHEREAS, during the City Development Council (CDC) meeting held at the Sangguniang Panlungsod Session Hall, on December 12, 2006, the said council passed CDC Resolution No. 2 S. 2006, entitled: "A RESOLUTION APPROVING THE REALIGNMENT OF TOURISM FACILITIES IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FUNDED UNDER 20% DEV'T.
