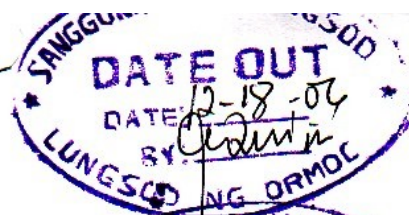
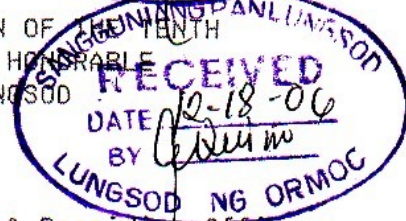

AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FUNDED
UNDER 20% DEV'T. FUND (2006 AIP) TO CONSTRUCTION OF
TOURISM INFORMATION CENTER IN THE SAME AMOUNT AND
REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE

WHEREAS, during the City Development Council (CDC) meeting held at
the Sangguniang Panlungsod Session Hall, on December 12, 2006, the said
