


RESOLUTION NO. 2006-270

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.
CODILLA TO RELEASE AND UTILIZE THE FOLLOWING AS
ASSISTANCE TO THE TYPHOON VICTIMS IN NAGA CITY AND
LEGASPI CITY, TO WIT:

- A) THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS
(P400,000.00) WORTH OF GOODS/FOOD ITEMS,
P200,000.00 WORTH OF GOODS FOR EACH CITY TO BE
TAKEN FROM OUT OF THE REMAINING GOODS WHICH WAS
PURCHASED DURING THE SEPTEMBER 2006 "MILENYO"
CALAMITY DISTRIBUTION OPERATION BY THIS CITY, AND;
- B) THE AMOUNT OF ONE HUNDRED THOUSAND PESOS
(P100,000.00) FROM THE 5% BUDGETARY RESERVE
(CALAMITY FUND) FOR FUEL AND OTHER EXPENSES IN
CONNECTION HERETO.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 13
December 2006 from the Office of the City Mayor, this city urgently
requesting for the passage of a resolution for the above-mentioned
assistance to typhoon victims in Naga City and Legaspi City;

WHEREAS, it can be recalled that the cities of Naga and Legaspi in
Bicol Region, suffered heavily from the fury of typhoon "REMIING" which
caused extensive damage to lives and properties;

WHEREAS, the City Government of Ormoc, mindful of the plight of the
residents of the affected areas sympathize with them and commiserates
with them in their time of need;




