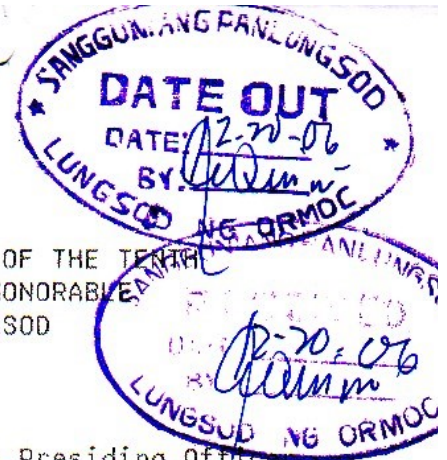

ADOPTED, December 19, 2006.


