


RESOLUTION NO. 2006-276

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO PURCHASE PROPERTIES LOCATED IN BRGY. ALEGRIA AFFECTED BY THE ROAD WIDENING FOR THE DISPOSAL AREA OF THE SOIL SPOILS FROM THE FLOOD MITIGATION AND ENHANCEMENT PROJECT OF A PORTION OF MALBASAG RIVER.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated 15 December 2006 from the Office of the City Mayor Eric C. Codilla urgently requesting for the passage of a resolution authorizing him to purchase properties affected by road widening for the Disposal Area of the JICA Rehabilitation/Enhancement Project of the Ormoc Flood Mitigation structure in Barangay Alegria, this city;

WHEREAS, the properties affected by the said project are as follows:

- a) Barangay Chapel, owned by Brgy. Alegria appraised at P552,000.00 per Resolution No. 2006-17 dated 06 December 2006 of the Appraisal Committee;
- b) Residential House, owned by Mr. Constantino Rosal, appraised at P498,960.00 per Resolution No. 2006-18 dated 06 December 2006 of the Appraisal Committee;

WHEREAS, this august Body believes that said request is reasonable and that the appraisal made on the aforementioned properties are fair, just and reasonable;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Public Properties, duly seconded by City Councilor Sotero M. Pepito; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO PURCHASE PROPERTIES LOCATED IN BRGY.
