## RESOLUTION NO. 2006-279

APPROVING ORDINANCE NO. 2006-00 OF THE RESOLUTION BARANGAY COUNCIL OF BARANGAY LILO-AN, THIS CITY, ENTITLED: "AN ORDINANCE REGULATING THE BACKYARD HOG RAISING OPERATION OF THE RESIDENTS OF THIS BARANGAY, TO MAINTAIN THE HEALTH AND SANITATION OF THE PLACE, AND TO AND PROTECT THE ENVIRONMENT, PROVIDING PENALTIES FOR THE VIOLATION HEREOF",

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance 2006-00, from the Barangay Council of Barangay Lilo-an, entitled: ORDINANCE REGULATING THE BACKYARD HOG RAISING OPERATION OF THE RESIDENTS OF THIS BARANGAY, TO MAINTAIN THE HEALTH AND SANITATION OF THE PLACE. AND TO PRESERVE AND PROTECT THE ENVIRONMENT, PROVIDING PENALTIES FOR THE VIOLATION HEREOF":
