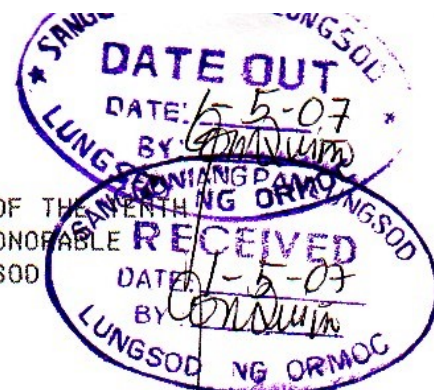

ORMOC CITY:


